

Governing board FAQs for parents

Do you understand how the school governing board functions?



What is the role of a school governor?

The main responsibility of a school governor is to ensure high standards of achievement for all pupils at the school. To do this, school governors have broad responsibilities to:

- Ensure the clarity of vision, ethos and strategic direction of the school.
- Hold leaders to account for the school's and pupils' performance, as well as the performance management of staff.
- Oversee the financial performance of the school, making sure money is well spent.

What does the governing board do?

The governing board determines:

- The vision and ethos of the school.
- Strategic priorities and targets for the school.
- That all pupils, including those with SEND, have access to a broad and balanced curriculum.
- The school's budget, including the use of pupil premium and sports premium.
- The school's staffing structure and key staffing policies.
- The principles to be used by school leaders to determine other school policies.

The governing board holds leaders to account by:

- Agreeing the outcomes of the school's self-evaluation, and ensuring they are used to inform priorities for the school development plan.
- Considering all relevant data and feedback on all aspects of school performance.
- Asking challenging questions of school leaders, such as "how will this decision impact pupils?"
- Ensuring leaders have organised the required audits and that results are shared. Ensuring leaders have developed the necessary policies and procedures, and the school is acting in accordance with these.
- Acting as link governors on specific topics, e.g. safeguarding, and reporting back to the governing board on the school's progress in relation to the specific topic.
- Listening and reporting to the school's stakeholders: parents, pupils, staff and the wider community.



The governing board also ensures that school staff have the resources and support they need to do their jobs well, access external advice, conduct effective appraisal and CPD, ensure the premises is suitable and that resources used have an impact.

When required, the governing board will:

- Appoint the headteacher and other senior leaders.
- Appraise the headteacher, set their pay and agree the pay recommendations for other staff.
- Hear the second stage of staff grievances and disciplinary matters.
- Hear appeals about pupil exclusions.

The governing board does not:

- Write school policies.
- Undertake any audits.
- Spend much time with pupils.
- Fundraise for the school, although the governing body must usually pay at least 10% of the costs of capital work.
- Undertake classroom observations to judge the quality of teaching.
- Undertake the role of school staff.

What are the different types of governors?

- **Head Teacher**
- **Chair** – the individual that leads the governing board. They are elected every year by the governing board.
- **Parent governor** – an individual who has a child of legal school age at the school, and is serving as a governor. They are elected by other parents at the school.
- **Staff governor** – an individual who is also a member of staff; usually elected by the staff to ensure that their views are represented on the governing board.
- **LA governor** – in maintained schools, an individual from the LA on the governing board. They are elected by the LA.
- **Foundation governor** – a governor elected by the diocese responsible for the school, including (ex officio) the Vicar of St Lawrence Church.

What is the structure of the governing board?

In Barnwood, the governing board consists of twelve governors, including the following:

- Two parent governors
- The headteacher
- One staff governor
- One LA governor
- Seven Foundation governors



How is the governing board elected?

Appointment – some governors (LA and Foundation) are chosen by appointment by the Local Authority or by the PCC of St Lawrence.

Election – some positions may be filled by election through voting systems such as a ballot; this is always conducted for parent and staff elections.

The governing board makes the following information clear when running an election for parent and staff governors:

- The core functions and the role of the governor; induction, training and development available and how governors will help them fulfill it.
- Expectations of governors in relation to a number of areas, e.g. frequency of meetings and term of office.
- Any desirable skills or experience.

As a parent, how can you get involved?

For an election, you'll be offered the opportunity to publish a statement setting out:

- The evidence of the extent to which you possess the skills and experience the governing board requires.
- Your commitment to undertake training and development and acquire new skills.
- How you plan to contribute to future work of the governing board, and contribution to date if it is a re-election.
